Please make the following corrections in the *Your Move* 2nd ed text.


Chapter 1: Movement, Stillness, Timing, Shape, Accents

- p. 4: The drawing of 1.3d needs to have the second action finish before count 5 to match the description in the text, "the actions . . . overlap by one count each."
- p. 19. In the description of Movement Patterns in Tine, change time values to "time lengths." The sentence should read: "Two studies in actions of different time lengths producing specific patterns in time."

Chapter 2: Traveling

- p. 28: The end of the second line under 2.1a and 2.1b. should read, "I once saw..."
- p. 28: Third line from the bottom of the paragraph across from 2.1c should read, "He (his whole being) had to be there." Not "his center."
- p. 29: top line: change "awaiting space" to "space to be used". The sentence should read, "Every room has space to be used."
- p. 38: Example 2.8h needs to be improved, the last part of the path should be more clearly a straight line to match the description in the fourth line from the bottom of the paragraph above the example.

Chapter 4: Absence of Support: Springing - The Five Basic Forms



- p. 95: Ex. 4.21a, 4.21c, and 4.21d one half of the forward take-off symbol is missing. Please fill in the sides and bottoms the forward symbol in each example as shown above.
- p. 99: Line 5 in the paragraph under the heading, Fighting Gravity, change "4.23b" to "4.23c"

Chapter 6: Direction - Broader Exploration of Space

• p. 150 Ex. 6.15h – delete dotted lines around hand, which indicate movement. The visual example in 6.15h is meant to show spatial variations in forward middle to match the description, "the vertical ad lib. sign next to the symbol stating more-or-less forward middle."

Chapter 8: Rotations, Revolutions, Turns

• pg 176, 177 (measures 1,2, 6, 9, 15), & 191. Change the two circles on top of one another in the body-as-a-whole symbol to more of a figure 8 as shown here - .

• p. 191: Review for Chapter Eight. Lower the spot hold in the 1¹/₄ wheeling symbol

Chapter 9: Supporting, Change of Support

• p. 213 in the block titled JOINTS, correct the "Any number" symbol to be less of a backward "S" so it appears more like the "any number" sign as shown here --

• p. 287. Change Reading Study No 35: Toward, Away, Destination to Reading Study #36: Addressing, Nearness, Touching, Grasping, Supporting, Grasping Support.

Chapter 13: Body Initiations: Central, Peripheral; Part Leading, Guidance

• p. 307 Change 13.11a to 13.11f and 13.11b to 13.11g.

Chapter 14: One-sided Gestures; Gestural Pathways; Gathering, Scattering

- p. 320. Replace Examples 14.60 and 14.6p with the new symbol for 'lateral circular gestural pathway either direction as shown to the right.
- p. 337. Make the same correction in the Review for Chapter Fourteen, bottom of the page: Lateral Paths Lateral circle either direction
- p. 328. At the end of the seventh line in the paragraph titled SURFACES, change Example 14.10h to 14.11 h.
- p. 334. In the first sentence at the top of the page, change "gathering" to "scattering" to match example 14.4l.

Chapter 17: Directions: The Diagonals

- p. 391 Ex 17.10g should be forward high for both examples (rather than blank)
- p. 411. Reading Study 55, end of measure 8, add the right foot stepping place middle as shown here.



p. 413, Review for Chapter Seventeen (continued). In the box titled <u>LIMB SIGNS</u> at the bottom of the page, the either or both signs should be centered under the symbol for the Legs, and centered under the symbol for the arms,

Chapter 19: Specific Directional Actions

• p. 453 Ex 19.12a. Cross out chest and insert head. The description should read "Small forward and backward head movements."
